- **Swimming shorts are strictly forbidden at the pool for hygiene and quality water.**
- **Animals : remember to bring the health passport.**



Rental conditions: Accommodation and pitch

1. All reservations are registered and can't be transferred.
2. The reservation becomes effective only after our confirmation and receipt of the deposit which is worth acceptance of the contract by the customer
Payment of the balance of the stay :
 - Camping, at the latest on arrival.
 - For rent : 30 days before the stay. In the absence of notice of delay and without payment, the location or rental becomes available 24 hours after the expected date of arrival on the contract. The reserved period will be charged, no reduction will be granted in case of delayed arrival or early departure.
3. Cancellation policy:

For rent :

- more than 45 days before the arrival date the deposit will be refunded less the administration fee;
- less than 45 days and more than 30 days before the arrival date, the deposit is retained
- less than 30 days before the date of arrival, you will still owe the full amount of the booked stay.

For a pitch :

- more than 30 days before the arrival date, the deposit will be refunded minus the booking fees
- less than 30 days before the arrival date, the deposit is retained.

An early departure during the stay does not give rise to any refund.

The request for cancellation must be made in writing by registered mail, it shall be taken into account upon receipt; It is possible to take out a cancellation insurance by the campsite. (Details of the guarantees on request or on www.campeze-couvert.com)

4. Guarantee :

In rental accommodation, a guarantee is required on arrival by check or CB imprint: 300 € for mobile homes and chalets; 150 € for the lodges, caraiibe and Coco Sweet. And a cleaning guarantee of 60 €.

These guarantees will be refunded to the official inventory (cleaning done by you) on departure at the agreed time (before 10 am in high season) or by mail. For your convenience you can book the end-of-stay cleaning package.

In the event of a non-conforming inventory, the client will have to pay the compliance (housekeeping and / or repairs) to resume his guarantee otherwise he authorizes the campsite to collect this guarantee.

5. Animals

Pets must be kept on a leash. Only the animals registered on the booking form will be allowed to stay, the management will refuse an animal not mentioned in the reservation. The up-to-date vaccination record must be presented on arrival. Maximum 1 pet per mobile home, maximum 20 kg. Dogs of 1st category are strictly forbidden within the campsite.

6. ARRIVAL/DEPARTURE

Rental: In July and August, arrivals are between 15h to 19h and the departures are organized after inventory of 8h to 10h00.

In off-season, the departure / arrival times are 10-12h / 16-18h depending on availability.

In the campsite: arrival between 14h and 20h, departure before 12h.

Please respect the time of return of your accommodation or pitch, otherwise we will be obliged to ask you a corresponding compensation of 50 € / h and to evict you).

7. INSURANCE AND RESPONSABILITIES

During their stay, the tenants benefit from the Civil Liability Coverage of the campsite La Chesnays for any personal injury or property damage that the campsite La Chesnays has been held responsible for.

Car parks on the pitches are free but unguarded. Only one vehicle is permitted on the site. The parking lot at the entrance of the campsite is unguarded.

The campsite La Chesnays therefore declines all responsibility in case of theft or degradation.

In any case, the number of people arriving in the hotel will not exceed the number of persons mentioned in the booking form. A child and / or baby is considered a person in the stay.

The pitches are limited to 6 people any additional person will have to take another accommodation.

Not more than 4 visitors at a time. All visitors must be declared at the reception. The Management reserves the right to refuse entry to anyone. Every tenant must be of age and responsible. He must be able to prove liability insurance.

Check that your home insurance includes the holiday guarantee to cover the possible damages of your vacation rental.

8. BBQ

For safety reasons collective barbecues are allowed, barbecues, electric plancha are prohibited. It is proposed to the reception of BBQ / plancha gas for rent.

9. SWIMMING POOL

Children must be accompanied by an adult and remain under the sole responsibility of the adult. The rules posted at the entrance to the swimming pool must be respected. **SWIMMING SHORTS ARE FORBIDDEN IN THE POOL.**

10. REGULATION

In order to facilitate your stay, all campers must respect the rules and regulations posted at the entrance of the campsite and the reception, a copy can be given to you on request.

11. RIGHT TO IMAGE :

You expressly and without compensation give the campsite permission to use any photos of you or your children that may be taken during your stay for advertising purposes. If not, please let us know by post at the latest at the end of your stay.
